**2014 Swimming Pool Rules**

1. Pool Season begins May 17th and runs through September 14th.

**HOURS OF OPERATION:**

The pool will be open daily from 9:00a until 8:30p\*\*

\*\*After Labor Day, the pool will be open daily from 9:00a until 8:00p

The pool will be staffed with an attendant during the following hours:

Saturday	12:00 p.m. until closing.
Sunday	12:00 p.m. until closing.
*Monday	12:00 p.m. until closing.
*Tuesday	12:00 p.m. until closing.
*Wednesday	12:00 p.m. until closing.
*Thursday	12:00 p.m. until closing.
* Friday	12:00 p.m. until closing.

\*On weekdays when public school is in session before Labor Day there will be one (1) attendant on duty from 4:00 p.m. to 8:30 p.m.

\*On weekdays when public school is in session after Labor Day there will be one (1) attendant on duty from 4:00 p.m. to 8:00 p.m.

Holiday hours will be the same as weekend hours. No one will be allowed in the swimming area unless the pool is officially open. Entering the pool premises when it is not open for resident use may result in the loss of pool privileges, fines, and/or prosecution to the fullest extent of the law.

2. The role of attendants is limited. THEY ARE NOT LIFEGUARDS. Therefore, members will be required to use self-governance and policing of themselves, family members and/or guests. Emergencies at the pool should be called in to 911 immediately. Behavior concerns of a non-emergency nature should be reported to the Attendant (upon arrival) or Management Office at (803)802-0004. Attendants when on duty will have authority to enforce all pool rules. Patrons who repeatedly violate the rules may be ejected and are subject to expulsion from the pool for the remainder of the season.

3. The pool is available for use **only by residents of Regal Manor HOA and their guests**. Residents must be current on their assessments. Pool access cards associated to delinquent accounts after May 24<sup>th</sup>, may be deactivated. Access cards may be reactivated by contacting the management office. Once payment has been received and account(s) brought current, access will be reinstated. (Re)activation may take up to 48 hours to process.
4. Residents shall enter the pool area using their access card. Patrons found opening the gate for unauthorized access may receive notice(s), fines and/or revocation of pool privileges.
5. Residents may only bring three (3), non-familial guests.
6. Residents are responsible for their guests at all times and must be present during guest usage.
7. **NO DIVING, RUNNING, PUSHING, OR HORSEPLAY OF ANY KIND AT ANY TIME.**
8. Patrons must wear proper swimming attire. Patrons dressed inappropriately will be asked to leave the pool area. (This is completely at the attendants' discretion and reviewable by the Board of Directors).
9. **No glass containers of any kind are permitted in the pool area.** Doing so can result in the pool being shut down by SC DHEC for the remainder of the pool season.
10. Children 15 and under entering the pool must be accompanied by a responsible adult resident 18 years old or older and must have proper supervision at all times in the pool area. **NO EXCEPTIONS.** Residents are encouraged to report unaccompanied minors to the attendant or management office. Repeat violations may result in expulsion from the pool for the season.
11. All Non-swimmers under the age of 15 must be accompanied by a swimming adult.
12. No throwing hard objects. Skateboards are prohibited inside the pool area.
13. Children who are not toilet-trained who wish to enter any pool must wear a disposable swim diaper. No regular diapers allowed.
14. Use of the kiddie pool is for children four (4) and under.
15. Food or refreshments may be consumed in the deck area. All refuse and waste papers must be deposited in designated receptacles.
16. Alcoholic beverages and/or drugs of any type are prohibited inside and outside the fenced area. Swimming after the consumption of alcoholic beverages/drugs is strictly prohibited.
17. Smoking is strictly prohibited anywhere in the pool area. A designated smoking area is located outside the pool area.

18. No playing on the ladders or float line.
19. Restrooms are available for residents and their guests. Please help us keep the restrooms clean and tidy.
20. Pets are not permitted in the pool area. Exceptions will be made for service animals.
21. Any injury occurring in the pool area must be reported to the pool attendant immediately.
22. The HOA is not responsible for personal property or valuables at any time.
23. The pool will close (at the discretion of the attendant) for any inclement weather.
24. **The decision of the attendant shall be final.**

**These rules are made for everyone's safety and enjoyment of the pool. Regal Manor Homeowners Association reserves the right to ask anyone in violation of any of the above rules to leave the pool or the pool area. Thank you for taking the time to read this information. We hope that you and your family enjoy the Community Pool this summer.**
